### WHAT IS THE ENVIRONMENTAL DEFENDERS

Mobilising support for environmental defenders (EDs) and finding ways to uphold their protection and that of the environment through sharing their campaigns for justice and highlighting the challenges EDs face, the tactics they employ and successful case studies for other EDs to learn from.



This is a media series using writing, photography, video and social media, to:

- create awareness of the causes and effects of environmental destruction
- bring lesser-known grassroots campaigns to English-speaking audiences
- report on environmental campaigning tactics
- improve transparency and accountability
- hold up case studies of success and failure to learn from
- motivate an international public to support environmental defenders' campaigns to protect the earth
- inspire action.

#### **ONLINE MEDIA**

Through motivational stories, impactful images and video, and accessible writing in English, we inspire the general public to defend the earth and protect its defenders.


We publish online articles, social media graphics and video content.



#### BOOKS

We will publish a collection of texts about the importance of protecting the Amazon: *The Amazon in Times of War* by Brazilian documentary-maker and researcher, Marcos Colón, and an autobiographical testimony *Terricide* by Mapuche land rights activist, Moira Millán.





### **INTERNATIONAL PARTNERSHIPS**

We'll facilitate international relationships between individuals, communities, and organisations through reporting, interviews, social media, and cross-publishing partnerships.


#### **TOOL FOR EMPOWERMENT**

We'll contribute to Global South-North learning by bringing knowledge from Latin American communities, journalists, photographers, and media outlets to a majority Global North audience. The series will also be a tool for researchers and students.



Established in 1977, the Latin America Bureau (LAB) is an online and in-print publisher and source of quality independent news about Latin America, focusing on struggles for social and environmental justice. We have published 185 books over the years –some of these have been translated into languages like Korean, Chinese, and Bengali– and LAB's established, respected platform allows English-speaking audiences to connect and engage with Latin American news.









### WHAT HAVE WE DONE SO FAR?

- The series began as a voluntary initiative within LAB. In October 2023 we won funding to work on the series for 6 months. This included:
  - Commissioning/publishing 12 original articles from international writers (e.g. in Chile, Surinam, Ecuador, Bolivia, Paraguay, Mexico and the UK)
  - Publishing inspiring, high-quality photographs to accompany original articles
  - Commissioning English translations of important reporting by our partner outlets about EDs' work in Latin America
  - Hiring a social media manager to create content to raise awareness of EDs' campaigns and direct users to our articles
  - Commissioning and publishing a mini-documentary amplifying the voices of 4 Black and Indigenous regional environmental defenders and their work.

#### • Topics covered included:

- Indigenous beekeeping in Mexico
- the Rights of Nature Movement in Ecuador
- activists in Suriname fighting to keep its 93% forest cover
- women water defenders in Mexico
- a Colombian community fighting to protect their forest from open-pit mining
- Indigenous communites in Paraguay employing ancestral knowledge and advocacy against the impacts of climate change

### WHAT HAVE WE DONE SO FAR?

#### • We have sustained decades of reporting on environmental protection and grassroots testimony,

• following in the footsteps of LAB books like *Amazon Besieged* by Mauricio Torres and Sue Branford, 2018 and *Voices of Latin America* edited by Tom Gatehouse, 2019.

#### • We have developed our coverage of resistance to mining in the region, publishing:

- the book The Heart of Our Earth: Community resistance to mining in Latin America by Tom Gatehouse (+ campaign events and press coverage in USA, UK, Chilean, Swiss, and Italian media)
- an article series by Linda Etchart on the rise of Narco-mining in the Ecuadorian Amazon and increased use of mercury which poisons rivers and the communities who depend on them
- o our translation of an interview with leader of Ecuador's first women's Indigenous Guard protecting the community from mining

#### • We've prioritised the voices of communities on the ground, including those of:

- 'Paĩ Tavyterã Indigenous communities employing ancestral knowledge and advocacy against the impacts of climate change in Paraguay
- Yuturi Warmi, the first Indigenous guard led by Kichwa women in Ecuador
- Kanan Ts'ono'ot collective in Mexico who demand cenotes are granted legal status and the Maya people named as their guardians
- Yuly Velásquez, a local fisher documenting water contamination and corruption linked to the Ecopetrol refinery in Colombia
- women of San Juan Bautista community struggling against a gas pipeline in defence of their lagoon, their land, and their existence as an Indigenous people.

#### • We've championed under-reported struggles, like:

- a Surinamese organisation's goal to keep the country's 93% forest cover intact
- a small Colombian community's fight against an open-pit mine in a little-known biodiversity hotspot providing countless towns with freshwater
- Xinka people in eastern Guatemala using legal strategies and tools to preserve their land and culture.



### THE IMPACTS OF OUR REPORTING SO FAR



Our international support for the community of Gualivá in Colombia helped mount pressure and the environmental authority cancelled the license to mine in an area critical for biodiversity.



#### Who will save Yasuní?

4th August, 2023

Ecuadorians go to the polls on 20 August 2023, to elect both a new president and 137 legislators for the country's National Assembly. They will also be given the choic to vote 'Yes' or 'No' in a referendum, wher 'Yes' vote will shut down all oil extraction i Yasuní National Park.



LAB's publishing around the Yes to Yasuní campaign contributed to the national decision to stop oil drilling in the Ecuadorian national park in August last year. We will continue to cover this issue to pressure the new Ecuadorian government to stick to their word.

### THE IMPACTS OF OUR REPORTING



We've boosted the public profiles of grassroots readers Lucia Ixchíu, Diego Aza, Millaray Huichalaf, Moira Millán and Yuturi Warmi, helping them win support to continue their work in defending the planet and attending key meetings like COP28, UN Youth Climate Action Meeting, and the UNFPII.




At a solidarity event we held for Moira Millán in London in April, we raised £600 for her cause and secured an interview with her about her work for BBC World Service which went out to 97 million people.









### THE IMPACTS OF OUR REPORTING



We've shared key tactics that can be replicated by other communities, like holding local referendums, using paraecology, documenting species, reporting rights abuses, mapping, and working with NGOs, civil society groups and universities.

Since starting the series, our social reach increased by over 125%



• We achieved 13.5k organic reach on Instagram reels related the series and 5.7k paid reach.



Engagement on social platforms increased by over 75% thanks to engagement with EDs content.



Crucially, this content is leading people to read the articles on our website and the average time people spent reading these articles is high: av. **1 min 30 seconds on EDs series articles** (the average engagement time on any webpage is only 52 seconds).



### WHY IS THIS PROJECT NEEDED? LEARN FROM LATIN AMERICA

- A continent of former colonies, Latin America has been plagued by extraction for centuries.
- All forms of extraction (minerals, oil, gas, timber, cattle, and plantation mono-culture crops) threaten to kill the ecosystems on which local communities and the whole world depend.
- There is therefore much to be learned from this key region for biodiversity, devastated by (often transnational) extractivism, home to Indigenous groups and Quilombo communities fighting to protect their land, culture, and sustainable practices.
- Mining in the region has increased exponentially in the last 20 years, bringing with it conflict with local communities, exhaustion and pollution of water resources, mercury poisoning, deforestation, and tailings dam collapses.
- The region's rich oil-fields offer tempting income for cash-strapped economies but at a high socioenvironmental cost. As the world moves to curb use of fossil fuels, the voices of (often Indigenous) inhabitants of these areas must be heard.



## WHY IS THIS PROJECT NEEDED? **INFORM, INSPIRE, ACT**

- Our project is urgently needed as it provides accessible, in-depth, non-specialist, creative commons coverage of issues often omitted from international reporting, otherwise unavailable to Western readers – who hold influential power in pressuring governments and companies to do better.
- Our project will help to raise the profile of lesser-known struggles. This international support can be leveraged by environmental defenders in their campaigns and negotiations (and has been – see *impact section*).
- Whereas much reporting on this topic and region is irregular and surface-level, we provide a platform to read the words of defenders themselves and to follow stories over time, long after they have faded from the attention of conventional news media.





### WHY IS THIS PROJECT NEEDED?

#### **ENCOURAGE PROTECTION FOR ENVIRONMENTAL DEFENDERS**

- In 2022, Latin America remained the world's deadliest region for EDs; on average, a defender was killed every other day (Global Witness, 2023)
- 36% of at least 177 defenders killed in 2022 were Indigenous and more than 1 in 5 of these killings took place in the Amazon. (Global Witness, 2023)
- Indigenous Peoples especially have a critical role to play in protecting nature. There is 50% less deforestation on Indigenous lands.
- "Organised crime has infiltrated the Amazon basin, seeking land for growing coca, rivers for drug trafficking and veins of gold underground. These groups are endangering the rainforest and the safety of those attempting to defend it." (Crisis Group, 2024)
- A large and rapidly increasing proportion of the deadliest conflicts are triggered by mining, both legal and illegal.
- Yet, projects and media coverage concerning the region in the UK are few and are often overlooked by funders. Mechanisms to protect the environment and its defenders, like the Escazú Agreement, have been designed, but they are not being put in place, as we report.

### WHAT ARE OUR AIMS?

- Inspire, inform, motivate and connect an English-speaking public with the stories of grassroots Environmental Defenders' work.
- Give environmental defenders (EDs) from countries where their battles are under-reported **a greater voice**.
- Report on successful environmental defence campaigns whilst committing to **document and denounce harm and human rights** abuses.
- Reach a wide audience through storytelling, imagery, crosspublishing partnerships, and social media management.
- Develop partnerships with trusted Latin American independent outlets reporting on EDs' work in regions which are underreported in Anglophone media.

- global awareness makes it harder for governments and companies to ignore often under-reported grassroots struggles.




- Expose the role of transnational corporations and **financial institutions** in extractive activities responsible for environmental destruction in an effort to address the root cause of the problem:


#### MARCOS COLÓN DOCUMENTARY-MAKER, ACADEMIC, WRITER

- Prioritising urgent storytelling with image-led article templates that showcase brave, inspiring stories and lead readers to action.
- Demonstrating wider context through easy navigation of topics on the ED website and smooth navigation to other LAB articles.
- Maintaining an easy-editing website that can host translations of articles published by partners as well as original content from our authors.

- Creating dedicated social media posts designed to inspire and inform and targeting specific audiences.
- Expanding our social media reach through the Yoast plug-in, allowing us to set more detailed SEO adjustments and meta-data, and easy sharing from the website to social media

## WHO AND WHAT WILL BENEFIT?

- The website will encourage awareness, reflection, and support among the **general public in the Global North** for environmental campaigns in the Global South, inspiring and informing local environmental struggles.
- Students, researchers, academics, journalists, activists, and policymakers can use it as an archive.
- Latin American grassroots campaigners, activists and their communities/habitats will benefit from increased awareness of their struggles especially when their lives/livelihoods are threatened.
- **Partner outlets** will benefit from their content being translated into English and shared among wider audiences, as well as by finding new content we provide to them about EDs' work elsewhere
- LAB will benefit by developing our work and our network will benefit from freelance work and connections.







**Global Witness** shares vital annual reports on threats to global environment defenders, but they do not focus on storytelling and testimony.
